## [3D Tech Dental Lab] - PRIVACY POLICY

### Personal information

## Collection and use of personal information

We may collect, hold, use and disclose personal information for the following purposes:

- for internal record keeping and administrative purposes;

# Your rights and controlling your personal information

**Choice and consent**: Please read this Privacy Policy carefully.
